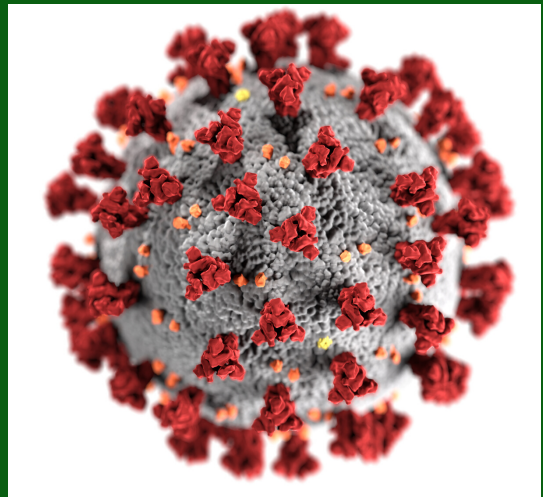
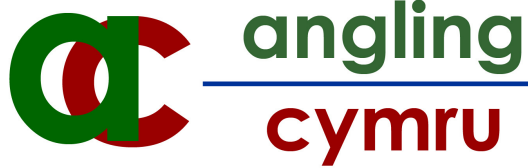
# Competitions Guidance

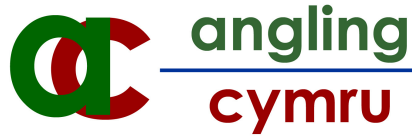

# General Organisation

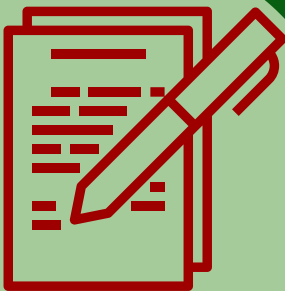


All angling competitions must only take place if the organisers can comply with Welsh Government Regulations on social distancing, gatherings, travel & sanitisation.

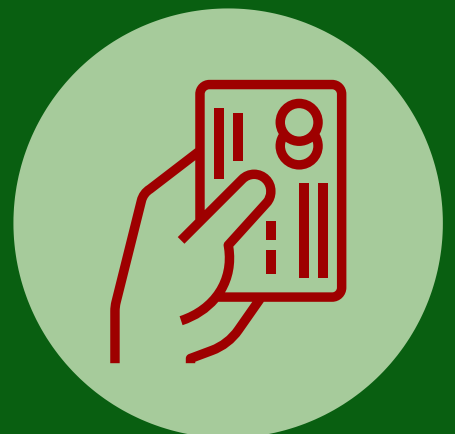
Competitors must be advised to stay at home if they or anyone in their household have any symptoms of Covid-19.



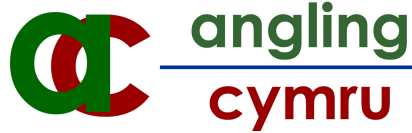
Organisers need to maintain a contact log of all competitors in case they are required for the Track & Trace system.



Organisers are advised to take competition bookings online or by phone. Online payments are also advisable where possible to avoid handling cash.

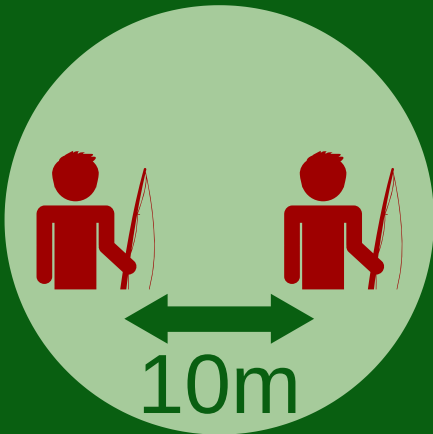


# Maintaining Social Distancing



Competitors must follow current restrictions when travelling to a competition. Think about parking - ask people to stay in their car if another angler is unloading & wait until they have left the car park. Similarly on return to the car park.

Organisers must ensure that current regulations on gatherings are complied with - no congregating before or after a competition at this stage.

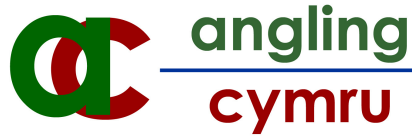


Organisers must ensure pegged competitions allow at least 10m distance between anglers.

Anglers walking to & from their peg should maintain social distancing at all times.

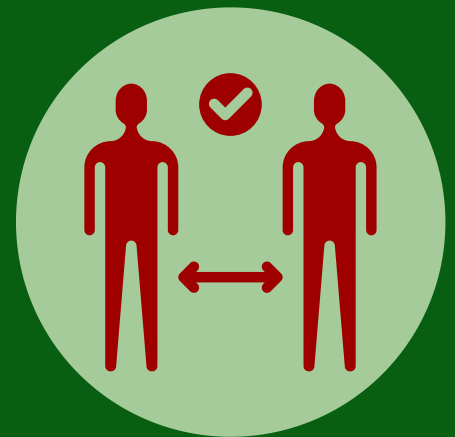


# Competition Management



Arrange competition bookings online or by phone. Ask anglers to pay online to avoid handing cash & contact with anglers where possible. Arrange for peg draws & results to be carried out online where possible.

Organisers should appoint officials to weigh &/or record catches. Use of PPE should be considered. Social distancing must be maintained at all times. Anglers should not share score cards.



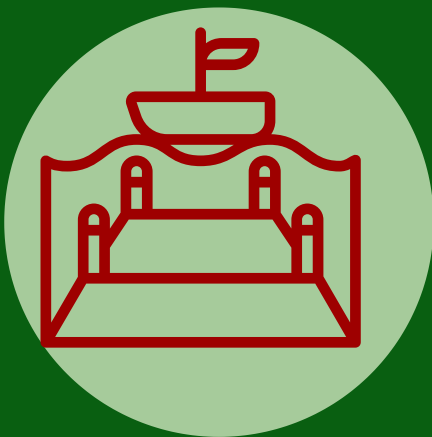
The angler should place their fish into the weighing vessel. The angler then steps away to allow the officials to weigh & record the catch. The angler should collect the fish & leaves the site, maintaining social distancing.

# Loch Style Competitions



Additional time needs to be considered to allow the phasing of start & finish times of the competition to ensure social distancing can be properly maintained.

Boats must be able to ensure that anglers are at least 2m apart.

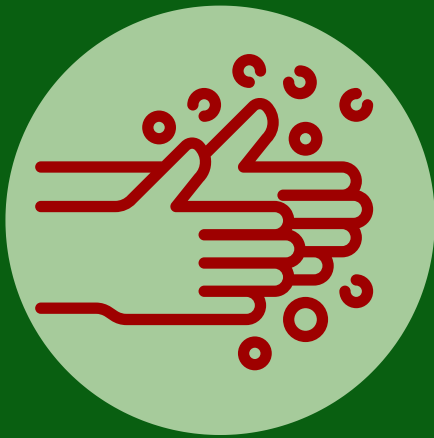
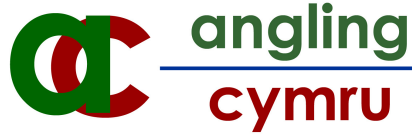


Organisers should arrange a designated area for boats to wait to disembark. This area should be marked to give clear instructions to anglers.

Organisers must ensure boats are cleaned thoroughly after each separate use. Welsh Government Guidance on sanitising procedures should be followed.



# Cleaning & Sanitising



Provide hand sanitiser or preferably, get anglers to bring their own. Encourage anglers to use it regularly.

Ask anglers to clean surfaces they have touched with hand sanitiser gel - gates, stiles, handrails etc. Any equipment used should be thoroughly cleaned and sanitised after use.

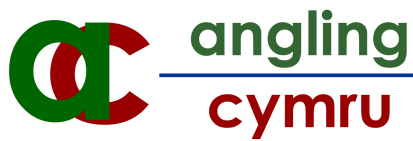


What Personal Protective Equipment do you need? Make sure you protect organisers & stewards whilst carrying out draws, weigh-in's, results & cleaning. Consideration should be given to carrying out First Aid. Welsh Government Guidance on PPE should be followed.

Ask anglers to bring a bin bag (or provide them) to take their rubbish home for disposal. For any further waste follow Welsh Government guidelines on bagging, storage & disposal.
